Language School: Sampath ji requested Pradeep ji to provide the updates on Tamil school. Pradeep ji's committee met with Tamil school group and discussed about Tamil school is part of HSCF, fee structures, rules and regulations. Pradeep ji mentioned that the negotiators were not able to come to an agreement.

eHe presented GC Policy & requirements prepared by him.

Other GC members replied that it was not approved in Previous GC. He also felt that the motion would be detrimental to unity and harmony in the community and not good for the temple. Sampath ji tabled the motion.
