Babuji garu went through the Ayyappa sanctum updates, the slope and extra step were both cut. Shilpis started Indianization work around the perimeter of the sanctum. Architects completed the drawing of the Indianization for Murugan Sanctum. Protective enclosure was made for Murugan sanctum. Met the contractor to review the renovation plans.

Devotee Madhaviji came to the GC Meeting and explained her concern about Priest Narayan Bhattar attitude when he came to perform the puja at her home. He behaved like he was above everybody and monopoly behavior.

Sampathji continued with his report and provided updates on Senior housing, we are expecting the approval preliminary plans by June.
