- Karthikji went through the Canteen upgrade plans and mentioned that the drawings are ready for submission. Some GC members asked for extra time to review the plans, to which Sampathji replied, 'Certainly, if GC members require more time.' The architect will come on Wednesday evening. Once everyone is okay with the plans, we will move forward.
- Ratha mandapam: Sampathji provided updates regarding the construction of the new Ratha Mandapam. Contract to build the mandapam awarded and new site was picked by GC. We will sell the old Ratham for an estimated amount of around 20,000 dollars.
- Sampath Ji invited all the GC chairs to Donor appreciation day, he noted that this years fund raising will be dedicated to ratham mandapam.
- Sampathji provided updates on the open Temple Manager position, indicating that efforts were made to hire a candidate. Unfortunately, the selected candidate declined the position as they secured another opportunity.
- The election process is in progress with Trueballot to fill up the GC positions.
- Security cameras have been successfully installed, and Maheshiji has been granted access to its functionality.
- Viren Ji questioned about temple CC payments for tamil school expenses. Sampath Ji explained that all the payments were made with the knowledge of the treasurer and the receipts were submitted.
- Sampath Ji further explained to Viren ji and Prashant Ji that GC had deferred the status of the language schools to GBM. But tamil school students are paying their fees directly to HSCF and HSCF is paying the expenses so that treasurer can properly account them.
